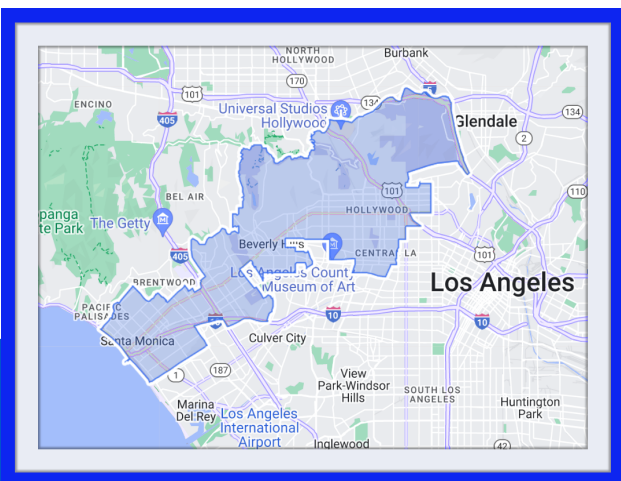

# New Laws Authored by Asm. Rick Chavez Zbur

## **AB 3 California Offshore Wind & Jobs Advancement Act**

Requires the California Energy Commission to study and recommend strategies for developing port infrastructure while maximizing in-state job opportunities and achieving our climate change goals through offshore wind energy while protecting cultural and natural resources.

## **AB 5 Safe & Supportive Schools Act**

Provides public school teachers and staff, who are on the front lines of supporting California students, with the training and support they need to better serve LGBTQ+ and all students.

## **AB 1484 Bargaining Rights for Temporary Public Employees**

Provides temporary employees of cities and counties the option to join existing bargaining units with permanent employees doing similar work, providing them with basic workers' rights without significantly increasing costs or limiting the employer's ability to hire temporary workers as needed.

## **AB 1620 Housing Security for Tenants with Physical Disabilities**

Authorizes local jurisdictions to require that tenants with permanent physical disabilities be allowed to relocate to an available unit on an accessible floor at the same rental rate and terms.

# JOINING ACTORS & WRITERS ON STRIKE

## A Historic Win for Hollywood's Unions

Everybody deserves a living wage, including actors, writers, and all the amazing Angelenos whose work contributes to the film industry and its historic legacy in Hollywood. I joined both WGA and SAG-AFTRA on the picket lines to demand fair wages for fair work. I am thrilled that studios and unions have reached an agreement, so that everybody can get back to doing what they love.





# MY AGENDA TO ADDRESS HOMELESSNESS

My bill package focused on legislation that will keep people in their homes while addressing some of the most vulnerable groups, including foster and LGBTQ+ youth, tenants with disabilities, and people at high-risk of eviction.

## AB 369 Independent Living Program for Foster Youth

- Young people aging out of the foster care system frequently experience homelessness. AB 369 brings California in line with 30+ other states by increasing the age for foster youth to receive support through the Independent Living Program from age 21 to 23. The bill also clarifies that young adults are allowed to accumulate cash savings while in extended foster care, better equipping them to successfully transition into independent adulthood.

## AB 1335 Regional Housing & Sustainability Planning

- Requires planning and reporting for sustainable housing development to be more transparent and makes clarifying changes so that housing and sustainability goals under the Regional Housing Need Allocation (RHNA) and Sustainable Communities Strategies (SCS) programs are better aligned. The bill will incentivize sustainable housing near transit to reduce our reliance on cars.

## AB 1431 California Housing Security Act

- One key to reducing the number of Californians experiencing homelessness is to empower people who are currently housed to stay in their homes. This bill will reduce housing insecurity by providing rent subsidies to low income former foster youth, older adults, adults with disabilities, people experiencing unemployment or homelessness, and recently incarcerated individuals. It requires the California Department of Housing and Community Development to establish a two-year pilot program to do this in up to four counties in different geographic regions across the state.

## AB 1620 Housing Security for Tenants with Permanent Physical Disabilities

- People with physical disabilities who are living in rent controlled apartments are at risk of becoming homeless if they become unable to access their home and cannot find a ground floor unit at a similar rental rate. AB 1620 will address this problem by authorizing local jurisdictions to require that tenants with permanent physical disabilities be allowed to relocate to an available unit on an accessible floor at the same rental rate and terms.

# Assemblymember Robert Rivas Sworn in as Speaker of the Assembly

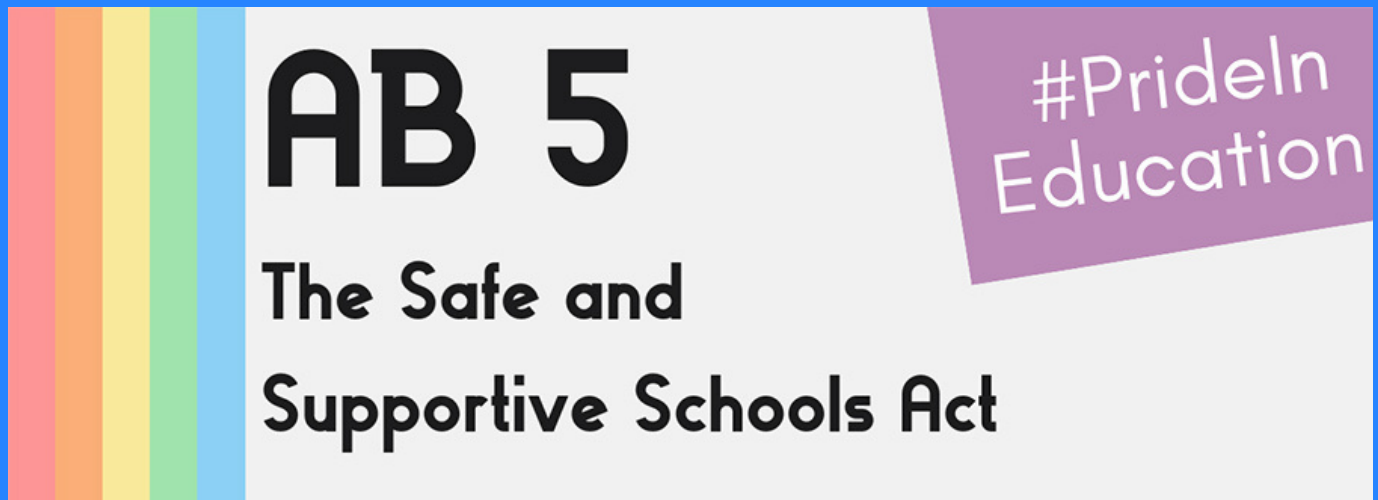

# *A Message on my Fight to Support & Protect our LGBTQ+ and Trans Communities*



As LGBTQ+ rights across the country come under attack, from book bans to outlawing instruction on sexual orientation and gender identity in schools, California is leading the way in preserving the rights of LGBTQ+ students across the state. While the state is making progress, LGBTQ+ students still experience harassment, violence and lack of affirmation in school settings far too often.

This is why I introduced the Safe and Supportive Schools Act on my first day in the State Assembly. AB 5 provides high quality, professional development opportunities to educators in order to help foster inclusive classroom environments and appropriately address the unique challenges that LGBTQ+ and all students face. The bill will help yield significant benefits for educators that directly transfer to the success of LGBTQ+ students and advance overall educational outcomes. Thank you, Governor Gavin Newsom for signing this bill into law.


